NewWorld Capital Group announces the initial public offering of SolarEdge Technologies, Inc.

SolarEdge Technologies, Inc. ("SolarEdge"), a leading global provider of DC optimizer and inverter solutions for residential, commercial, and utility-scale solar installations, completed an initial public offering of stock on March 26th. The offering raised \$150 mm of capital and was led by Goldman Sachs and Deutsche Bank. SolarEdge was priced for trading on the NASDAQ on Thursday, March 26th, at \$18.00 per share and traded up to \$20.70 per share by close of business yesterday, a 15% gain.

NewWorld Capital Group, LLC holds a significant minority interest in SolarEdge and has worked with the Company's management team to support its further development. NewWorld completed an investment in SolarEdge in September 2014.
