Astrum is an East Coast based residential solar installer with industry-leading installation and customer acquisition costs, high levels of customer referral, and striking capital efficiency. NewWorld sourced and negotiated the original investment and led the exit transaction after eight months of ownership.

Astrum is the eighth largest residential solar installer in the nation. The Company designs and installs solar photovoltaic arrays and provides ongoing operations and maintenance services, partnering with third-party lease and loan providers to offer its customers cost-effective financing. Astrum's marketing excellence and software-enabled management systems have allowed the Company to grow rapidly across the East Coast, while offering best-in-class quality and performance.

With this transaction, Direct Energy is moving into the U.S. solar market. A subsidiary of Centrica plc, Direct Energy is a large energy retailer with a commitment to offering a broad range of energy services to the residential and commercial energy markets in the United States.

Recent declines in the installed cost of residential solar, coupled with continuing high retail electricity prices and availability of residential customer financing, have opened up a vast market of homeowners who can adopt solar energy to immediately reduce their electricity bills. The U.S. residential solar market is less than 5% penetrated today and is forecast to grow at 30% per year over the next several years.
